## Rules of the Castleford RUFC Members 200 Club Development Fund

### The Fund

- Castleford RUFC Members 200 Club Development Fund (the Fund) is a separate fund administered by the General Committee of Castleford RUFC. The proceeds shall be used for the sole purpose of development of rugby at Castleford RUFC (the Club) and at the sole discretion of the General Committee.

### Participants in the Fund

- Participation in the Fund will be restricted to Individual Members and Family Members of the Club as defined in the Club Constitution or family and friends of such as introduced to participate in the Fund.
- Participation in the Fund conveys no voting rights under the Club Constitution.
- The Participants agree to pay by a one-off payment of £60 or set up and maintain a direct debit or standing order of a monthly payment of £5 and for a period of one year to the Club for the Fund.
- In consideration of each one-off payment or direct debit or standing order set up and maintained the Participants will receive a Members 200 Club Participant Number and that number will be entered into a Monthly Draw.
- For the time being a maximum of 200 Participant Numbers will be issued and a Participant will be restricted to no more than 5 direct debits or standing orders and subsequent Participant Numbers. Should there be more than 200 applications for Participant Numbers then the General Committee shall consider issuing more numbers accordingly.
- The Participants have no claim on the Fund other than the amount of their cash prize resulting from the Monthly Draw.
- If for any reason a Participant's number is drawn out in the Monthly Draw and the Participant has not made the necessary payments to the Club for the Fund then the cash prize will be utilised to settle any outstanding payments due.
- By making the one-off payment of £60 or setting up and maintaining for one year the direct debit or standing order and receiving a Participant Number the Participants agree to abide by these Rules of the Members 200 Club Development Fund.

### Monthly Draws

- Every month there will be eight cash prizes, a first prize of £100, two second prizes of £50 each and four third prizes of £25 each, and paid to the 5 Participants who have maintained their payments to the Club for the Fund and whose Participant Numbers are drawn out for the first, second and third prizes respectively in the Monthly Draw.

## **Castleford RUFC Members 200 Club**

- The Monthly Draw will be made each month. Notification of the drawn numbers will be by a notice on the Club notice board and website and winners must contact the Club to arrange to collect their prize.
- There will be no restrictions on the number of times that a Participant in the Fund can win a prize in the Monthly Draw.
- In the Monthly Draw made in December the first prize will be £250 rather than £100.
